Mappers use a GIS mapping platform called DistrictBuilder, and the DTL website ([drawthelinespa.org](http://drawthelinespa.org)) contains a host of resources to support their effort.

Pennsylvanians can then submit their maps to a competition every semester, where they have a chance to win a prize from the statewide purse of \$23,575. Their maps are judged by a volunteer steering committee made of a diverse range of respected civic, business, and political leaders from across the state, representing all ranges of ideology. After drawing their map, Pennsylvanians can share it with their elected representatives to urge reform. Ultimately, DTL is a project that demonstrates that the voters of PA are ready, willing and able to do this core work of democracy.
